

# Wednesday 2025/2026 Waste Collection Schedule



Place your waste at the curb in front of your property between 7 pm the night before and 7 am on your scheduled collection day. Bring all empty containers in from the curb by 7 pm.

 Regular Pick-up Day: **Wednesday**

 **Statutory Holiday:** Waste collection will occur one day later than regularly scheduled if it falls on or after a statutory holiday.

 Natural Christmas trees are collected curbside on your pick-up day.

 Circular Materials will be responsible for the Blue Box program on **April 1, 2025**. Further changes can be expected **January 1, 2026**.

 **December 1, 2025**, is the last week of curbside yard waste collection. Collection **resumes the week of March 2, 2026**, on your pick-up day.
